



RELEASE AND INDEMNITY AGREEMENT

This agreement is made between SANBAR dressage (hereinafter referred to as Stable) and _____ (hereinafter referred to as Undersigned). If the person is under 18 years of age, the signature of the lawful and legal parent or guardian indicates acceptance or responsibility by said parent/guardian and release of liability of Stable. The word Stable is used in this agreement to include landowners, stable owners, stable managers, trainers, independent contractors, clinicians, employees, and any other individual related to ownership or management of the horse facilities called SANBAR dressage.

1. INDEMNIFICATIONS AND RELEASE

The Undersigned do indemnify and release SANBAR dressage from liability for:

- a. Any accident or injuries sustained by me, my employees, heirs, representatives, agents, dependents, guests, or animals.
- b. Damage caused to the Undersigned's property or horse(s).
- c. Damage to persons, property, or other horses by Undersigned's horse(s).
- d. Physical loss or injury or damage causing death or making destruction necessary to horse(s) in Stable care.
- e. Consequences of ordinary negligence.

2. RESPONSIBILITY/KNOWLEDGE

As a horse owner, student, contestant, spectator, employee, independent contractor, parent or guardian the Undersigned recognizes that all equestrian-related activities, including but not limited to riding, grooming, walking, grazing, and viewing, involve inherent risks and are extremely dangerous. In light of this knowledge, the Undersigned assumes full responsibility for:

- a. All harm that comes to them, their children, animals, associates, and guests. Horses are unpredictable and may suddenly kick, bolt, knock over such that you might land on your head or back or worse. Children may jump, run and play such that they are injured.
- b. The release of Stable from any and all harm for accidents or injuries or harm to horse, rider or property.
- c. Purchase of and daily compliance to, wear while riding or near horses, an ASTM/SEI certified riding helmet, to prevent injury or death from fall or other horse related occurrence. **MINORS MUST WEAR HELMET WHILE RIDING OR NEAR HORSES.**

3. FINANCIAL RESPONSIBILITY

The Undersigned agrees that they:

- a. Have adequate medical and liability insurance and/or financial protection.
- b. Will cover losses occasioned by the injury or death of rider, spectator, guest, horse, or other property.
- c. And their heirs, representatives, dependents, or guests shall have no right or action against Stable or any of Stable's insurance carriers.

4. PERSONAL PROPERTY

It is understood and agreed that Stable assumes no responsibility for the Undersigned's personal property (tack, trailer, vehicle, etc.) and its use and said property is stored on the premises at the sole risk of the Undersigned.
